

## Program Administration

---

The day to day operation and long term planning of the Northeast Pennsylvania Urban Forestry Program was directed by the Morris Arboretum and supported by the Pennsylvania Department of Conservation and Natural Resources (PA DCNR), Bureau of Forestry through the State Forester, James Grace.

Program administrators from the Morris Arboretum were Bob Gutowski, Director, Public Programs, Brooks Mullahy, Associate Director, Center for Urban Forestry, Donna Murphy and Wayne Lucas, Program Coordinators, Kelly McLaughlin, Administrative Coordinator, and Amanda Subjin, Administrative Assistant. Anthony Santoli, Lackawanna District Forester represented the PA DCNR.

### **Morris Arboretum of the University of Pennsylvania**

The Morris Arboretum of the University of Pennsylvania is an educational institution and historic public garden that promotes understanding of the relationship between people and plants. The Arboretum's major activities are teaching, research, outreach, and display. The Arboretum and the USDA Forest Service have an effective and longtime partnership that dates back over 60 years and brings together the resources of an internationally known arboretum and the Forest Service. Each enhances the other's capacity to effectively deliver information and technical assistance to a broad range of constituents.

At the time of this Program, the Center for Urban Forestry at the Morris Arboretum was one of three Regional Centers of Excellence in urban forestry. These Centers conduct urban forestry advocacy, education, research, and demonstration programs serving local, state, and regional needs. As local, regional, and national resources, they provide information and services on federal, state, and local levels and to public and private organizations.

The Morris Arboretum Center for Urban Forestry provided program administrative services that included:

- directing the Program,
- managing the grant proposals and evaluation process,
- administering sub-grants,
- monitoring grant performance,
- providing technical assistance to the projects,
- providing a local Program Coordinator, and
- providing a local Program office.

## **Penn State University Cooperative Extension Service**












Many grantees benefited from the assistance of the Penn State University Cooperative Extension Service through Urban Forester, Vincent Cotrone. Services focused on helping communities with active Shade Tree Commissions or Committees’ applications for Tree Liability and Assessment Grants and helping those communities implement their projects.

Grantees received plant selection assistance, inventory training, educational information, and hands-on assistance with volunteer plantings. Large Grant recipients received assistance with volunteer plantings, demonstrations, and assistance with streamside restoration techniques. Penn State Extension Service was very helpful to the local program coordinator by providing assistance with contractual problems, quality control, and soil issues. Educational handouts and product information were available to the Program on a project need basis.
